WHY I AM APPLYING FOR THE UK BUSINESS VISITOR VISA FOR THE EXAM

I have worked as a doctor in India for more than 2 years; now I want to work as a doctor in a better system where I can improve my skills even more. There is no doubt in the fact that the UK's healthcare system is one of the best healthcare systems in the world. I seek opportunities to further enhance my clinical skills by working in an environment of skillful doctors from the UK.

After gaining a sufficient amount of knowledge and experience as a doctor, and after serving the UK for a few years, I would like to come back to India to help the people of my country, like many others have done before me.

WHY I WAS UNABLE TO BOOK PLAB 1 EXAM IN INDIA

I attempted my first IELTS exam held by IDP India on xx date but failed to achieve the requirements for GMC Plab 1 exam bookings. I attempted two more times in the next 4 months, only to achieve success on xx date.

Since the Covid-19 pandemic, the exam slots for Plab 1 have high competition. In my case, no slots were available for the coming year (2022). However, after untiring attempts, I was lucky to book a seat on xx date for Sheffield, UK to be held on xx date (canceled by someone).

As per GMC, the available slots can be seen only once the current exam bookings are cancelled. Additionally, GMC quotes- "the Demand for test places is high and this may affect availability for your preferred date or venue".
